ALL TIME HIGH TAX COLLECTION OF PKR 20 billion in 2021-22

WITH RECORD GROWTH OF 33% THIS YEAR.

Quetta (Balochistan): The Balochistan Revenue Authority (BRA) has surpassed its all-time revenue collection records by achieving this year target of PKR 20 billion in the financial year 2021-22.

The BRA, established in year 2015, has successfully become the premier tax collecting agency in the province and collected PKR-20 billion during the financial year 2021-22.

Despite the fact that the province has no large manufacturing and industrial base, nor it has big agro and services sector coupled with covid, inflation, recession and economic melt down around the globe and so in the country and the province of Balochistan; yet with all time support of the Government of Balochistan, the Chief Minister Mir Abdul Quddus Bezinjo and the Chief Secretary, Mr. Abdul Aziz Uqaili and the Finance department, the Secretaries Finance Mr. Adbul Rehman Buzdar and Hafiz Abdul Basit; the BRA has achieved the unprecedented year over year growth of 33% ; Where as only this years collection constitutes the 29% of the total collection by BRA since its very inception back in 2015.
